COVID-19 case numbers are rising rapidly across the whole of the UK and in other countries. We must act now to control the spread of the virus. The single most important action we can all take to fight coronavirus is to stay at home, to protect the NHS and save lives.

When we reduce our day-to-day contact with other people, we reduce the spread of the infection. That is why, from Thursday 5 November until Wednesday 2 December, you must:

- 1. Stay at home, except for specific purposes.
- 2. Avoid meeting people you do not live with, except for specific purposes.
- 3. Close certain businesses and venues.

These new measures will reduce the growth rate of the virus, which will:

- prevent the NHS from being overwhelmed
- ensure schools, colleges and universities can stay open
- ensure that as many people as possible can continue to work

On Thursday 5 November, these national restrictions replaced the Local Covid Alert Level measures.

The new measures will apply nationally for four weeks up to and including Wednesday 2 December. At the end of that period, we will return to a regional approach, based on the latest data.

Remembrance Service, Wednesday 11th November

Due to the current COVID-19 restrictions, the Parochial Church Council and Birlingham Parish Council have sought guidance on holding a remembrance event this year. Official guidance from the Government is available on-line and Wychavon District Council has issued its own guidance; Services should not be open to the public and attendance should ideally be restricted to a maximum of six people; there should be no parades and wreath laying should take place outside the normal remembrance time of 10.30-11.30am. As a result, both Pershore and Eckington have decided to cancel their normal Remembrance Day parades and services and it is with regret that Birlingham has decided to do the same.

In light of this, the day will be marked as follows. A solitary church bell will be rung and a closed service (maximum of six invitees and not open to the public) will be held in the church. The Revd Steve Dunton (Abbey Curate) will lead the prayers and will read out the names before the altar. This way villagers will know that the memory of their dead are still being marked by the Church in these difficult times. Village residents are asked not to congregate at the war memorial and instead are encouraged to mark the occasion at home by joining in the two-minute silence at 11.00am. Wreaths will be laid at both the Birlingham and Eckington war memorials at some time after the service but not immediately following it. It has also been suggested that residents might like to decorate the war memorial with flowers over the days leading up to 11th November as was done for the VE celebrations.
